



Fees and Refunds



At the time of publication, the Enrollment Fee is \$26 per unit (Example: a 3 unit course is \$78)

Note: All fees are subject to change. Enrollment Fees are set by the California Legislature.

Registration Fees

.5 unit or more.....	\$17 per term - Refer to Health Services Center for services.
Non Resident Tuition.....	\$190 per unit plus other registration fees.
Course/Material Fee (if applicable)	\$ Varies – As shown in current schedule of classes under course title.

* **Enrollment Fee:** Waived for BOGG recipients.

****Health Fee:** Pursuant to Education Code and district policy, Southwestern College has a mandatory health fee. The health fee is \$14–\$17 per term for each student depending on the number of units taken. The health fee and/or health fee exceptions are subject to change should the state legislature take action to change them. Any student who depends exclusively on prayer for healing in accordance with the teachings of a bona-fide religious sect, denomination or organization is exempt from paying the health fee. Students on AFDC, SSI, or General Relief may request exemption. High School students enrolled at the Sweetwater Union High School district taking designated classes at high school sites only may request exemption. Students attending under an approved apprenticeship training program may request exemption exclusive online courses. Upon request, the health fee will be refunded to any student who withdraws from all courses prior to the 10% date of the length of the course.

Note: The fees listed below are those in effect at the time of printing. Enrollment fees are subject to change through California State Legislation and other fees through Southwestern College Governing Board actions.

Accident Insurance/Liability Fee.....	\$2

Returned Check Service Charge

Checks returned for non-sufficient funds or “Stop Payments” must be paid by MasterCard, VISA, Discover, cash or money order, and a \$25 service charge will be added to the amount of the check. Your enrollment at Southwestern College, as well as your credit, may be affected.

Refund Policy

A student will be refunded registration fees for any program changes (withdrawals) made by the 10 percent point of actual class meeting days. Please check with Admission for dates specific classes.

Refund Deadlines

*(Pursuant to Section 58508 of Subchapter 6 of Chapter 9 of Division 6, Title 5 of the California Code of Regulations).

Parking permit must be returned to the Cashier’s Office within the refund deadline to receive a refund.

Students who officially withdraw from class by the refund deadline will be mailed a refund. It is imperative that a current address be on file in Admissions. Refunds may take up to four weeks after the add/drop period.

Note: Refunds must be made by the refund date (located on the Important Dates and Deadlines page).

Refunds for Fast Track classes have a refund period of 10% of the actual class meeting days, which in many classes is the first day of classes.
