Report: 11.1 Alyssa Cox, ASO Executive Vice President

Alyssa Cox reported that this is the last report for the year which included accomplishments: this year student oriented. goals were student-oriented this year; first shuttle service for San Ysidro and cross border; waiting for student satisfaction survey results; vegan wraps being sold at cafeteria; scholarships administered for programs; marquee board will be replaced; hydration stations; ordered bookshelves for lending library; ASO elections; new executive position will be appointed—VP for Outreach (will be eight ASO execs next year); food pantry; ASO stress relief week; president and student trustee will meet once a month; ASO Banquet on June 1.

12. ACADEMIC SENATE REPORT

Report: 12.1 Professor Patricia Flores-Charter, President, Academic Senate

Patricia Flores-Charter noted it was her last Board meeting. She provided a list of major accomplishments: local graduation requirements removed; Distance Education plan implemented; permanent CTE college committee; CTE bi-annual report implementation; compressed calendar; academic program was reorganized; reviewed academic policies and procedures; bookstore textbook college committee; revised emeritus policy procedure?; creation of three Action Improvement Plans (AIPs) for accreditation; CMS vote; Marsha Rutter memorial. She added still on the table: resolve equity and diversity crisis; develop a viable enrollment management plan; get off warning and get reaffirmation of accreditation; Policy 7120 revamp; roll out academic program review with Elumen; improve rate of district response to Senate for needs. She thanked the Board for its interest in faculty matters and for the questions from the Board.

Board President Vargas stated it had been an honor to work with her as academic senate president.

13. UNION/ASSOCIATION REPORTS

Report: 13.1 Professor Frank Post, President, Southwestern College Education Association (SCEA)

Frank Post acknowledged Student Trustee Rodriguez and stated it was a pleasure to work with her. He noted that it was his last Board meeting and thanked the Board, Superintendent/President Nish, faculty and administrators. He indicated that SWC has a lot of work to do and that there were a lot of good people. He thanked the Board for phone calls, coffee. He noted not to shy away from the truth, don't push things under the carpet. He noted that incoming SCEA President Rob Shaffer would be coming in the day after graduation.

Board President Vargas thanked him for being an advocate for faculty.

Report: 13.2 Andre Harris, President, California School Employees Association (CSEA)

Presentation to CSEA Job Stewards

Andre Harris noted this presentation is during Classified Employees Week is the third week of May, and the theme is every day heroes. He introduced in attendance Joni Collins who recognized CSEA Job Stewards (Andre Harris, Silvia Lugo, Elizabeth Valdez). Vickie Kimbrough thanked Student Trustee Rodriguez for her service and stated that she did an outstanding job.

Report: 14.1 Kathy Tyner, Vice President for Academic Affairs

VP Tyner thanked Student Trusted Rodriguez for her service and thanked colleagues, including Patricia Flores-Charter. She reported summer would start in a couple of weeks and 500 sections would be offered. She provided an FTES report for 15-16 (15,100 FTES projected, not quite base, but will see what happens with summer.) She reported on College Preview Day (evaluations from 300 of 600 students showed 99% indicated it was valuable and informative). They are already working with SUHSD on a new date for next fall. The dance department hosted 90 SUHSD students in a dance class. She shared that Kathleen Canney Lopez attended a career technical talk at San Diego City College. VP Tyner's report is uploaded in BoardDocs.

Report: 14.2 Tim Flood, Vice President for Business & Financial Affairs

VP Flood thanked Student Trustee Rodriguez and SCEA President Frank Post. He expressed his appreciation to Academic Senate President Patti Flores-Charter for working with him on the Budget Committee. He reported that for Business and Finance it was all about the budget this week. He noted the Budget workshop to be held on Thursday (during college hour). He reported that they are starting to close down the year. He referred to a position on the docket that was key to this division—Director of Payroll, who he noted straightened out the backlog of STRS issues.

Report: 14.3 Karl Sparks, Interim Vice President for Employee Services

VP Sparks reported they should have something about the VP HR recruitment next week. He acknowledged great cooperation from union leaders and ASO President and expressed his appreciation for that. He indicated that he would make notes of suggestions and leave recommendations. He shared that he would work on beginning a process for an improvement program beginning with Human Resources which will start in the next couple of weeks with performance review.

Report: 14.4 Angelica L. Suarez, Ph.D., Vice President for Student Affairs

VP Suarez echoed the comments expressed for Student Trustee Rodriguez, who she noted had been exemplary. She thanked outgoing Academic Senate President Patti Flores-Charter and SCEA President Frank Post for their leadership. VP Suarez reported this is the month of student recognition, and she thanked the Board for attending various events. She noted the DSS ceremony tomorrow. She highlighted that a record number of 816 students are participating in commencement this year, as compared to 700 last year. She noted that her Board report was submitted electronically.
