Campus Safety

Southwestern College is a safe institution where education thrives. Faculty, staff members, and students should feel secure in this positive and supportive environment without the fear or threat of crime, hazards or disruptions. However, crime does occur from time to time.

- Violent crime on campus is rare. A number of notable Crimes Against Persons incidents were reported in 2017:
 - Attempted kidnapping of a female juvenile student walking on campus
 - Robbery of a cellular phone from a Barry's Security Guard
 - Sexual Battery incidents of unwanted touching
 - Rape, other sexual assaults not reported
 - One incident of Domestic Violence
- Property Crimes are more common and are usually crimes of opportunity. These include:
 - Grand and petty thefts
 - Hit and run incidents
 - Vandalism
