

# INTERNATIONAL COMMUTER STUDENT APPLICATION Mexican Nationals/Commuting from Mexico to the United States

We appreciate your interest in Southwestern College. We are also pleased to provide you with the following information pertaining to our international student program.

Southwestern College is a two-year public community college located in Chula Vista, a suburb of San Diego, California. The college is approximately 15 kilometers east of the Pacific Ocean on a mesa above the Bonita Valley. The college provides post-secondary education and offers a wide variety of day and evening courses to assist students in achieving their educational needs.

#### APPLICATION DEADLINE

• Must apply a minimum of 1 month prior to beginning of term (*Please foresee that there may be delays when scheduling an appointment with the U.S.Consulate*).

#### **GENERAL INFORMATION**

- Students will be admitted for full semester, fast track (second eight-week session), or summer. NOTE: application must be submitted at least a month before session begins
- Students must declare an Associate Degree major. Students may not enroll in English as a Second Language (ESL) courses
- Applicant must be a high school graduate equivalent to a U.S. high school graduation and have a 3.0 GPA. U.S. college transfer students must have 15 completed units with a 2.5 GPA.
- Applicants must present a minimum of 50 points on the Internet-based TOEFL test (IBT) or 5.5 on the IELTS. Additional TOEFL information may be obtained at the TOEFL website: www.ets.org/toefl. IELTS information is at ielts.org.
- Applicant must submit an affidavit of support

#### ADMISSION REQUIRMENTS

Must verify permanent residence in Mexico (e.g.: driver's license, utility bill, voter registration).

Must declare an educational goal (select a major from academic program list)

Must verify affidavit of support for cost of tuition and other fees (\$8,735.00 per year)

Submit high school and/or college transcripts.

Must have TOEFL/IELTS scores mailed to Southwestern College

Submit 300-to-500-word personal statement listing educational goals and why you want to attend SWC. Submit a \$100 non-refundable application fee.

Must maintain residency in Mexico (not authorized to live in the U.S.)

## Other Requirements

International Students are required to:

- 1. Attend a pre-registration orientation
- 2. Receive educational counseling prior to registration
- 3. Take the College Guidance Placement Tests
- 4. All International Students must become familiar with the regulations of the Immigration and Naturalization Service (INS) and **assume responsibility** for complying with those regulations.

#### **Academic Requirements:**

- 1. Enroll in, *maintain and complete* a maximum of 11 units per semester
- 2. Must maintain a 2.5 Grade Point Average (GPA) on a 4.0 scale.

#### COST

- Tuition varies every semester. Refer to swccd.edu/fees for current fee listing.
- Students must purchase textbooks and other related instructional supplies.

#### \*NOTE:

Required fees will vary depending on length of study. Please attach to your application financial proof covering the total amount indicated above. If you plan to attend various semesters, the total amount of all semesters should be reflected on the financial statement. (Example: If you plan to attend 4 semesters:  $\$8,735 \times 2 = \$17,470.00$ . Therefore, the required financial proof you must submit should be \$17,470.00)

#### **APPLICATION FEE**

Send a non-refundable fee of \$100 in a U.S. check or money order payable to Southwestern College. If you are admitted to the college, the \$100 fee will be applied toward your tuition and fees during the first semester of attendance.

#### **ACCEPTANCE**

#### I-20 Form Issuance- Certificate of Eligibility for Nonimmigrant (F-3) Student Status

A Congratulations Letter and an Immigration Naturalization Service (INS) form I-20 will be sent to you after you have met all of the admissions requirements. To avoid delays in receiving your form I-20, please notify our office immediately if you have changed your mailing address since application.

Take your Form I-20 and valid passport to the United States Consulate in Tijuana to apply for an F1 visa (student visa). For applicants who already posses an F1 visa and an I-20 form from another institution, the International Student Advisor will instruct on how to complete your transfer to Southwestern College.

#### **ORIENTATION**
