  - Board Member Salcido moved, seconded by Board Member Dominguez to approve the budget as presented.
  - Salcido amended motion to include 7% reserves based on Board Member Aguilar's comments.
  - Board Member Aguilar entered a substitute motion to adopt the tentative budget in compliance with current Board policy with a 7% contingency reserve and to direct the Superintendent/President to make adjustments in the tentative budget to conform to that 7% minimum and make adjustments consistent with discussion held tonight, further that the budget be submitted to the County Superintendent of Schools on or before June 30 in accordance with legal requirement. The motion died for lack of a second.

Board Member Salcido withdrew her amended motion to include 7%.
