A Copy of your Selective Service registration acknowledgment (available after registration with Selective Service at www.sss.gov).
<input type="checkbox"/> I am a Veteran.	Attach a copy of your DD214, Member 4, indicating "Honorable" discharge status.
<input type="checkbox"/> I entered the U.S. after the age of 26 years old and have not registered for Selective Service.	You must attach Proof of date of birth ; and ONE of the following documents; <ol style="list-style-type: none"> Proof of immigration date to the U.S. from an entry stamp on the I-94 form or on the passport, OR A letter from the U.S. Citizenship and Immigration Services (USCIS) indicating the date you entered the U.S.; AND For those in the U.S. on a valid visa who are at least 18 and less than 26 years old, a student visa form (I-20) or other valid U.S. passport visa stamp with expiration date (the dates must be from entry until after you turned 26).
<input type="checkbox"/> I am over 26 years old and have not registered for Selective Service.	You must attach: A Status information letter obtained from www.sss.gov AND a written statement explaining your failure to register for Selective Service. Please make sure you address the following in your statement: <ol style="list-style-type: none"> Where you lived when you were 18 through 25 years of age. Whether you thought you were registered, if so, why and attach any supporting documentation. If you were not aware you were required to register, why and how you were not aware of the widely publicized requirement to register for Selective Service.
<input type="checkbox"/> I entered the U.S. on a valid nonimmigrant VISA and remained under the same status until my 26th birthday.	You must attach: Documentation that indicates that you were admitted on an F-1 visa and attended school full-time as required. Acceptable documentation includes a copy of Form I-20 or a letter from the school you attended indicating full-time attendance as a nonimmigrant alien. The same applies for all nonimmigrant statuses.
<input type="checkbox"/> I have not registered with the Selective Service because I am exempt for the following reasons:	<ol style="list-style-type: none"> I was assigned the gender female at birth. I have not reached my 18th birthday. I was born before 1960.
