RESOLUTION NO. 1991

RESOLUTION OF THE GOVERNING BOARD OF THE SOUTHWESTERN COMMUNITY COLLEGE DISTRICT ENTERING ELECTION RESULTS INTO THE MINUTES AND CERTIFYING TO THE BOARD OF SUPERVISORS OF SAN DIEGO COUNTY ALL PROCEEDINGS IN THE NOVEMBER 8, 2016 GENERAL OBLIGATION BOND ELECTION

WHEREAS, the Governing Board of the Southwestern Community College District (the “District”) previously adopted a resolution requesting San Diego County (the “County”) to call an election for general obligation bonds (the “Bond Election”) to be held on November 8, 2016; and

WHEREAS, such resolution was duly delivered to the Registrar of Voters and County Clerk-Recorder; and

WHEREAS, notice of the Bond Election was duly given; and

WHEREAS, on November 8, 2016, the Bond Election was duly held and conducted for the purpose of voting a measure for the issuance of bonds of the District in the amount of \$400,000,000 (“Proposition Z”); and

WHEREAS, the Governing Board of the District has received from the County’s Registrar of Voters/County Clerk-Recorder the Canvass Certificate and Official Statement of Results (the “Canvass”) of the Bond Election; and

WHEREAS, it appears from the Canvass, a copy of which is attached hereto as Exhibit “A,” that more than fifty-five percent of the votes cast on Proposition Z were in favor of issuing the aforementioned bonds.

NOW, THEREFORE, THE GOVERNING BOARD OF THE SOUTHWESTERN COMMUNITY COLLEGE DISTRICT DOES HEREBY FIND, DETERMINE AND CERTIFY AS FOLLOWS:

Section 1. That entry be made upon the minutes of the meeting that Proposition Z has been approved by more than fifty-five percent of the votes cast at the Bond Election.

Section 2. That all proceedings of the District in connection with the Bond Election have been accomplished according to law.

Section 3. That the Secretary of the Governing Board is hereby requested to deliver a copy of this Resolution with the Canvass to the County’s Superintendent of Schools and the Clerk of the Board of Supervisors.
