# **OVERVIEW**

The Governing Board, at its meeting held April 24, 2013, accepted the Facilities Master Plan (FMP). Contained in the FMP are specific projects, including small projects that require architectural services for design and construction document preparation. Anticipated small project Architectural Services include the HEC Otay Mesa Storage Building, Police Security Building, and the design and submission of miscellaneous core site amenity projects to Division of State Architect for review and approval as required.

In consideration of professional service requirements related to architectural design services, the District Staff conducted a Request for Qualifications (RFQ) 138R for On-Call Architectural Services, which included small architectural services projects. From the resulting list of 23 pre-qualified firms, the selection committee identified the three (3) most qualified local firms for the Small Project Architectural Services for participation in RFP 1314-1003R and subsequent interviews with the committee.

# Process:

The selection committee for this RFP interview process consisted of Mark Claussen, Proposition R Program Manager, Silvia Cornejo, Dean, Higher Education Center at Otay Mesa and San Ysidro, Ronald Ungar, District Professor/EMT Program Coordinator, Joseph Stengel, Proposition R Senior Project Manager, and Linda Hernandez, District Planning & Facilities Coordinator (non-voting Observer of Process), who were responsible for reviewing the scope and responses to the RFP, participating in interviews, and selecting the firms for contract award.
